For those donors who wish to make a long term impact on our sport, all donations of at least \$120 per year (or \$10 per month) including lump sum cash donations and planned gifts, are eligible for a donor incentive program through Sask Sport. To qualify for the incentives, these gifts must be deferred

annual priorities, or be held in trust for a long

Gifts which are deferred for five years will have an additional 20% of the total value of the donation added to the contribution up to a maximum of \$5000.

Also, donors may choose to have their donation used for short term (1-2 years) priorities or kept in trust for a minimum of 5 years to help ensure the future of the sport of gymnastics in Saskatchewan.

also willing to work closely with the donor to create a personal and lasting legacy or tribute of the donor's choice.



Gymnastics Saskatchewan is the provincial sport body which governs artistic gymnastics and trampoline sports in the province of Saskatchewan. Our mission is to promote and guide gymnastics in Saskatchewan for the pursuit of excellence and lifelong participation. We were incorporated in 1975

and are active members of Sask Sport and Gymnastics Canada.

Athletes of all ages and abilities enjoy participating in gymnastics programs offered by clubs, recreation associations, communities and schools across Saskatchewan. Gymnastics Saskatchewan currently has over 9,000 members. These individuals participate in one of our 80 club

programs in over 250 communities in the province.




Saskatchewan records show that gymnastics was thriving as early as 1904. In the 1920's and 30's the YMCA's in Regina and Saskatoon had competitive programs. Competitive Y programs continued until well into the 1970's. In 1958, a new era began with women starting to compete, and the Y's no

monopoly on gymnastics in the province.

Private clubs began to appear as the need for more training time and better training facilities became evident.

In 1958, the first Saskatchewan Open Championship was held in Regina with ninety-four gymnasts from across Western Canada in attendance.

Since 1960, Saskatchewan gymnasts have participated in provincial, western and national championships. For a consecutive seven year period (1961-1967) various Saskatchewan athletes proudly held the title of "national champion". Since 1962 over thirty Saskatchewan athletes have been named to national teams and have represented Canada at prestigious events such as Olympic Games, PanAm Games, FISU Games and World Championships.

These athletes were ambassadors for our sport, our province and their local communities and clubs. Our Odyssey Fund will allow our current young athletes to become our future World and Olympic level performers and carry on the tradition of excellence established by those that came before them.

- foster recreational program opportunities for fun and or the development of fitness and fundamental skills for lifelong participation


