Hello Clubs,

The Saskatchewan Small Business Emergency Payment Program – Phase 2 was just announced. The application forms will be available at 12:00pm on Monday December 7<sup>th</sup>.

The maximum payment is \$5000 per business and to be eligible a Saskatchewan business must:

1. Have been carrying on business in Saskatchewan on October 31, 2020;
2. Maintain a permanent establishment in Saskatchewan and pay income tax to Saskatchewan;
3. Have been ordered to temporarily close or substantially curtail operations through a COVID-19 public health order;
4. Have less than 500 full-time and part-time employees;
  - o In the year before the public health order; or
  - o When averaged for the 3 years before the year in which the public health order was made;
5. Attest that they:
  - o have experienced a loss, or will experience a loss, in sales revenue from business activities from December 1 to December 31, 2020, due to a public health order; and
  - o plan to reopen or continue operations following the cancellation of the public health orders.
6. Apply before January 31, 2021.
