6. 2022-2022 AUDITED STATEMENT

The audited statement was previously circulated to clubs.

Hillary Neiszner (Audit/Finance Committee member) presented a brief report and highlighted the financial statements.

- Gym Sask had a successful year financially, mainly due to the quick recovery from Covid in terms of membership numbers and membership revenues. Annual Funding and MAP grant revenue was stable.
- Some expenses were reduced as several events and major competitions were still held virtually, resulting in no team travel costs to Gym Sask.
- Challenges include the still rising costs of liability insurance for members, and other member service costs such as Socan and Resound licensing continue to significantly increase.
- Gym Sask was able to top up our three reserve funds this year, with money set aside for emergency or other planned use.
- The audit committee, made up of Hillary Neiszner, Nicole Zimmer and Brian Nestman, along with the rest of the Board are pleased to receive a clean audit report, with no concerns expressed by the auditor on financial policies, procedures, errors or omissions.
